

### IMPACT IN ACTION

Coalition Builds inspire leaders from trucking companies, truck stops, bus companies, public transit agencies, energy companies, transportation associations, government agencies and law enforcement agencies to act, while equipping them with the practical tools they need to become force multipliers in the anti-human trafficking movement.

#### **Since the Midland Coalition Build:**

- TAT facilitated introductions between law enforcement and a local service provider to assist a potential survivor of human trafficking and further an investigation.
- Homeland Security Investigations El Paso connected TAT with several other Special Agent in Charge (SAC) offices throughout the United States for inclusion in Coalition Builds and invited TAT to present on a podcast.
- ConocoPhillips hosted TAT for safety leadership and safety contractor meetings in North Dakota.
- EOG Resources sponsored a Freedom Drivers Project event in Houston with the Children's Assessment Center.
- Phillips 66 requested additional materials to distribute to its teams in the Permian Basin, encouraged its contract carriers to train with TAT, and registered 700 truck drivers as trained through its wholly-owned subsidiary, Sentinel Transportation.
- FBI Lubbock requested TAT's law enforcement modules and joined the local human trafficking task force.
- SLB continued training all of its new drivers with TAT materials through its Kellyville Driving Center. To date, SLB has trained over 3,000 truck drivers.
- Precision Pipeline, LLC (PPL) continued training employees with TAT materials. To date, PPL has trained 8,865 employees.
- SandBox/US Silica continued training all of its new drivers with TAT materials. To date, SandBox has trained 3,200 employees.
