TAT celebrates its birthday at the Mid-America Trucking Show

TAT took the Freedom Drivers Project (FDP) and its 15th birthday party to the Mid-America Trucking Show in Louisville March 21-23 to include the trucking industry in its celebrations.

"We did prize drawings for Retro TAT gear and gift cards, asked people to take photos and do short interviews with us for our birthday, telling us why they're TATs," said Heather Fry, TAT Industry Training director.

Fry spoke at the Women in Trucking's (WIT) "Salute to Women Behind the Wheel," manned a booth with TAT materials in the WIT area and did an interview on the Dave Nemo Show. Micah Larsen, TAT's FDP specialist, provided a human trafficking presentation on the last day of the show.

Walmart Transportation sponsored the FDP's presence and provided 28 volunteers from the Walmart Women in Trucking (WIT) drivers, the Walmart Road Team and instructors to help with the exhibit. Four hundred and twenty six people learned about human trafficking by touring the exhibit.

UPS and TAT team up for four events in March




At the Ontario UPS Rodeo, UPS drivers spruced up the Freedom Drivers Project after its travels and before tours began.

UPS and TAT teamed up for four events in March, including UPS Rodeos in Goodyear, Arizona and Ontario, California, as well as two Atlanta events, one with youthSpark (another UPS partner), and a UPS SMARTHub Rodeo. TAT's Freedom Drivers Project (FDP) attended every event, and UPS provided all the needed hauls.

On March 2, 117 employees and family members toured the FDP at the UPS Rodeo in Goodyear, had conversations surrounding the importance of increasing awareness of human trafficking and enjoyed watching the Feeder Drivers showcase their driving skills in competition at the rodeo. In Ontario, California on March 9, another 87 employees and family members visited the exhibit throughout the day of competition.

The FDP then traveled to Georgia and, along with FDP Director Brandy Belton, took part in *youthSpark Drives Change in Fulton County* on March 15. youthSpark, founded initially as the Juvenile Justice Fund in 2000, has a long record of historic Georgia firsts in the fight against child sex trafficking. Both TAT and youthSpark receive funding from The UPS Foundation, and this is the first time the two organizations have collaborated on an event.

Open to the community, this event honored youthSpark's decades-long partnership with the Fulton County Juvenile Court and featured presentations by a number of youthSpark's current partners, including the Fulton County Juvenile Court, Fulton County Sheriff's Office, Clerk's Office, and Solicitor's Office. Belton also spoke, as did youthSpark leadership and Homeland Security Investigations/Human Trafficking Officer Davin Stewart. Of the 80 people in attendance, 69 toured the FDP.

The following day, Belton and the FDP joined UPS SMARTHub employees and Safety Drive for a Cure at their second annual trucking rodeo event, which included both Package and Feeder drivers. One hundred and fifty drivers competed for state championships and to support Safety Driver for a Cure, which sponsored the Pediatric Brain Tumor Foundation.

"Many drivers came and spoke to me at the FDP, toured the exhibit and even cried while walking out," shared Belton. "With the help of UPS drivers Ryan Ybarra and Al Pedregon, who volunteered at the FDP as well as competed, 135 people toured the exhibit."

California Sexual Assault Investigators Association hosts TAT at training conference

Dylan Wecht, TAT Public Sector Engagement specialist, and Kelley Alsobrook, TAT training specialist, presented at the California Sexual Assault Investigators Association (CSAIA) Spring 2024 Training Conference in Pismo Beach, California on March 13. This is the first time TAT has presented to this organization.

Wecht and Alsobrook conducted a four-hour training for 170 in-person attendees and 28 virtual attendees. Comprised mainly of law enforcement with between one and 20 years experience, the audience also included medical/nursing personnel, prosecutors, parole and probation officers and social services. Audience members received a variety of TAT materials and resources for distribution throughout the state. Additionally, the CSAIA expressed interest in bringing back TAT training at future conferences.

Wecht commented, "This conference brought together sexual assault detectives from all over the state. These detectives are the individuals who have the power to lead demand-focused initiatives within their communities, investigate the rising prevalence of online-based trafficking cases and use the victim-centered approach when building their case and assisting the prosecution in obtaining a conviction."

He continued, "While this group of attendees are not necessarily the ones who are pulling over vehicles or working a beat, they are the ones who take over the investigation, interview the victims and perpetrators, obtain and look through the evidence, work with the prosecution, and, ultimately, have a massive stake in the case at hand. The feedback from the audience was tremendous. In addition to thanking Kelley for her bravery in sharing her story and being a difference-maker, several attendees approached both of us with specific questions about ongoing cases, how to best work with victim advocates and how to guarantee the safety and security of victims in the long-term. Every law enforcement officer has the potential to make a tremendous difference in a victim's life, and it's important for TAT to work with the various levels and sectors of law enforcement as certain training elements will be more relevant to certain groups."

Audience survey results gave the speakers and content between 96-98.9% in every category, with 100% noting that the training met their expectations.
