

To date, TAT has partnered with 26 state directors of pupil transportation, 11 of whom have taken steps to implement TAT training statewide for all school transportation employees. These states include Alabama, Florida, Georgia, Hawaii, Idaho, Illinois, Indiana, Iowa, Kansas, Kentucky and Tennessee.

# WIT Accelerate! Conference continues to inspire attendees to fight human trafficking

At the Women in Trucking (WIT) Accelerate! Conference Nov. 9-12, TAT had the opportunity to connect with women and spread awareness on how the trucking industry is combating human trafficking. Survivor Leader/TAT Training Specialist Kelley Alsobrook and Director of Industry Training Heather Fry presented to a standing-room-only packed room, which highlights TAT's growing visibility within this industry sector. Alsobrook shared her livedexperience as a survivor of sex trafficking, and Fry spoke of giving the audience hope in the midst of a difficult topic, stating that TAT's program is working, and the trucking industry has the power to make a difference in the lives of victims of human trafficking.

Reflecting on this breakout session, Rachel Ellenberger from the North American Council for Freight Efficiency (NACFE) commented, "The presentation was emotionally raw, but in a way that wasn't for the shock value; it was to show the reality and severity. Heather did a fabulous job speaking, and Kelley was a fantastic speaker, and I greatly admire her bravery in sharing her story. It is so important for TAT to show up at events like this because this is such a pervasive issue that is very easy to overlook if you're not focusing on it."

Lisa Kroger of Great West Casualty added, "I went to TAT's presentation at WIT, and it's so wonderful to hear, not only the stories of those that shared their experiences, but just to get to know the people that are also helping in that organization. It really is a tribe that is making a difference for all of us."



Brandy Belton reported that 531 people toured the FDP as part of the Truck & Technology Tour, and Fry and Industry Training Program Specialist Chris Moreno manned a table and talked to hundreds of people on how their companies can get involved. The TAT team noted that, compared to last year, many people came to the booth and FDP aware of the work that TAT is doing and already engaged through their companies' initiatives with TAT.

Training Specialist/Survivor Leader Kelley Alsobrook provided the WIT audience insight into human trafficking from a survivor's point of view.
